- January 2 (Tuesday) Deadline for filing for School Board 5:00 p.m.
- April 1 (Monday) Publish notice of election (Press Star publication on March 28)
- April 2 (Tuesday) Election
- April 22 (Monday) School Board members take office

Members receive points by attending the State Education Convention, participating in workshops and a variety of other professional development activities.

budget.


B. Discussion on high school roofing replacement process

Child Development Days

On Thursday, October 12, 2023, the special education team conducted one of their child find activities. Child Development Days took place at Lincoln Elementary from 8:00 a.m.- 5:00 p.m. Over 30 families brought in their students aged 2.5 to 4 years old to be screened in multiple areas including: gross and fine motor skills, speech, communication, cognition and medical concerns. The early childhood staff organized this activity, and they were supported by our school psychologists, speech and language pathologists as well as our occupational and physical therapy department. ACCESS for ELLs Testing

ACCESS for ELLs is an English language proficiency assessment administered to Kindergarten through 12th grade students who have been identified as English language learners (ELLs). It is given annually in Wisconsin to monitor students' progress in acquiring academic English. ACCESS for ELLs testing window is about to open. Students will be testing this year from December 4, 2023, through February 2, 2024.

Second Quarter Begins - Report Cards

November 4, 2023, marked the last day of the first quarter for our students. As a reminder, quarter grades are sent home via Thursday folders for grades K-4. Grades 5-8 can be monitored via Family Access. New London High School reports grades on a semester basis.

Instructional Committee

The Instructional Committee met November 8, 2023. During this session we discussed a request to modify and enhance our current computer science

course. The year long course will become 2 semester courses and will evolve to include more components of game design in the second semester. This will not only allow students who have room for a semester course to add it over multiple years, but will also enhance this career



pathway. This request was supported by the committee and the changes will be reflected in the 2023 course guide.

During the rest of the meeting we reviewed the Career Pathways document to help illustrate all 16 career clusters. Finally we spent time reviewing the school report card format, details and the local data that we use to guide analysis and action in preparation for our report card public release later this month.

School Report Cards: Parent's Right to Know



On November 14, 2023, the state releases the public School Report Cards. As required, we will post and share results on our website and through

Skyward Family Access to assure all families receive the ranking scores identified by the State. I will be sharing a pre-service slideshow to help understand the public release and how to interpret the report. Remember since this report is a normative bell reset each year by the data collected, our goal is always to remain Meeting Expectations and looking for manners to impact our local data as a result.

During the November Board of Education Special Meeting, we will do deeper analysis including local data. Once this is covered at the meeting, our Notices page will also be updated with the latest scores and links.

Rural Virtual Academy



New London virtual students continue to work through the RVA curriculum with continued communication with our district. Parents who are looking to have students

connect receive a digital newsletter.

Current enrollment includes 21 full-time enrollments, and course enrollments that include meeting the needs of our ELL population and summer school courses. RVA continues to ask for input on how they can support and grow to meet our local needs for instruction and opportunities that we cannot facilitate alone.

Brett Pickarts, our new Alternative Education
Teacher at the ISMS and Jacqueline Schommer,
lead teacher of Next Generation continue to explore
manners to get more out of this partnership. Some
celebrations from our first quarter included the use of
Kaleidoscope gifted and talented activities for
engagement and enhancement of students during
IE, educational and leadership opportunities with
summits and field trips, and the opportunity to use or
reference hybrid or online curriculum to build or
support our current course offerings. These new
options have added 88 students in custom
engagement activities and moves our impact to 76
students served.

I would encourage the board to invite Brett or Jacqueline to report out later this year on their insight into the RVA partnership and potential.

Library Plan

Our library team works diligently to monitor and update our library plan annually. This includes data monitoring; patron use, circulation, alignment to curriculum, student achievement levels, teacher requests and interconnected themes among other items. Beyond traditional materials they also work to integrate and support technology in the classroom, use of databases, and model research techniques.

This year, the State of Wisconsin is asking us to submit a copy of our library plan by adding it to our district website. Our team will present on that plan in our second meeting of this month after we do an audit of requirements noted on the request. Sincere thanks to both our library and our technology teams for their work on the Future Ready Library

components. After this review, we will continue to keep the plan on the noted website location and add it to items reviewed annually with our other educational options.
